# What does the Foundation do?

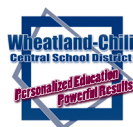
**Created in 2002, the Foundation is a 501 (c) (3) nonprofit organization that provides funding for:**

Of course, we didn't know what to expect, and realized the potential for a very difficult year. Well, as it turns out, generosity and compassion won the day, leading to another banner year for our Foundation.

Let's start with the students. Last February, our scholarship applications increased 9% over the previous year. I am proud to announce that last May, our Foundation Board awarded 17 \$5,000 Make All the Difference Scholarships and three \$500 Awards for a total of \$86,500. I want to thank our Scholarship Review Committee for the many hours reviewing the highly competitive applications, and for participating in a very successful virtual conference. Please enjoy our featured scholarship/award recipient excerpts in this report.

Next, our Board recognized the importance of acknowledging and celebrating our student recipients, even amid health precautions that prevented our typical in-person spring-time reception. Due to a very creative Reception Committee and the outstanding efforts of BOCES 2 support staff, we conducted a wonderfully successful "Drive-Thru Reception" on June 15 at the BOCES 2 campus. Students received a gift basket, met our scholarship sponsors, were congratulated by their school district superintendent and had a commemorative photo taken.

Moving into fall, we faced our biggest hurdle. How to approach fundraising and sponsorships related to our Annual Celebration. We were concerned about the impact of financial and unemployment issues in the community. However, considering the importance of raising these funds, and the higher likelihood of financial burdens on our students and families, our Board decided to go to you our sponsors and donors, asking for whatever financial support you could give. In addition, our Celebration Committee under the leadership of Jo Anne Antonacci and Leigh Nenni launched our very first virtual auction held November 2-14. Suffice it to say, we were overwhelmed by the incredible response. Despite these difficult times, our Foundation yielded approximately \$50,000! On behalf of the Foundation Board and the students and families served by our Foundation, thank you to our generous and cherished sponsors, "Friends of the Foundation" donors and virtual auction participants! Your generosity as a caring community transcended the barriers and heartbreak of this pandemic.

Finally, our Foundation Board members have been a collective "rock," taking on these many challenges. They have been tireless in their efforts and remain an energetic, caring and dedicated Board. We would like to thank two departing Board members for their outstanding service, Rachel Magar and our long-time and very devoted Board Secretary Dee Alexander. The resource room was pretty much 1:1 and helped me to understand my work better, and they re-explained what the teacher said so I could better understand it. My teachers and advisors made me realize I can achieve anything I work for. The time in high school prepared me to the future, I have all the tools I need to be on my own in the college world and to continue to grow and be a better person. I learned to advocate for myself, when I don't understand something or when I need extra assistance, I seek people out and get what I need. If I didn't have those supports, I probably would have to be in high school another year. People actually took the time to teach me instead of letting me fail.

# Many Paths TO GIVING

The Monroe 2–Orleans Educational Foundation is a 501 (c) (3) nonprofit organization. Gifts to the Foundation are tax deductible. There are many ways to positively impact our students by donating to the Foundation:

## **Bequests, Life Insurance, Retirement Plans**

These options allow donors to make gifts using assets upon their death. Bequests allow you to designate a specific amount, a percentage of your estate, or all of what remains after you consider others. Bequests will allow you to reduce estate taxes. The Foundation may also be named as the beneficiary of a life insurance policy, or be given a retirement plan principal or income.

## **Cash Gifts**

Most donors make their gifts and pledge payments by check or cash. For tax purposes, the gift date is the postmark date on the envelope, or the date the check is hand-delivered.

## **Charitable Gift Annuities (Life Income)**

Making a life income gift can allow you to maintain or increase your income. This income can be paid to you, and then to your spouse or another individual for his or her lifetime. You receive the immediate tax benefits, and the Foundation receives your gift when the life income payments are complete.

## **Commemorative Gifts**

Contributions to the Foundation are a great way to recognize a special individual or commemorate a significant event. The Monroe 2–Orleans Educational Foundation gladly accepts gifts made in honor or memory of an individual. Special recognition giving cards are available.

## **Corporate Matching Gifts**

You may be able to double or triple your gift if you work at or are retired from a company that has a matching gifts program. Please contact your employer's human resources office for forms and information.

Tax laws allow you to give appreciated securities and take a tax deduction for current value, and generally bypass capital gains taxes that would be due if you sold them, making it more cost-effective to contribute a gift.

## **Qualified Charitable IRA Distribution**

A qualified charitable distribution is a charitable contribution from an IRA made directly to an eligible charity. The owner of the account isn't taxed on it which gives your donation added impact for the Foundation. Please contact your financial and/or tax advisors for further guidance on this type of donation.

## **Real Estate**

Your home, land and other real estate may be used to make an immediate or life income gift. As with appreciated securities, real estate gifts held more than a year can offer significant tax benefits. The value of your gift will need an appraisal, required by the IRS.
